This invitation is directed both to entities offering comprehensive systems dedicated to broadcasting sports events and to companies supplying only components - e.g., only cameras or only software - that can be integrated with other elements of the required infrastructure.

PZPN INFORMATION CLAUSE FOR REPRESENTATIVES AND CONTACT PERSONS IN THE PERFORMANCE OF THE CONTRACT

1. The Polish Football Association declares that, in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation - RODO) (Official Journal of the EU L 2016 No. 119, p.1), as Polish Football Association with its registered office in Warsaw, Bitwy Warszawskiej 1920 r. No. 7, 02-366 Warsaw (hereinafter referred to as "PZPN"), is the Data Controller of the representatives and persons designated for contact within the framework of the performance of the Agreement.
2. In matters of data protection, the data protection officer designated by the Polish Football Association may be contacted by e-mail: daneosobowe@pzpn.pl, or by mail: Polish Football Association, 7 Bitwy Warszawskiej 1920 roku Street, 02-366 Warsaw.
3. The data of representatives and contact persons will be processed by the Polish Football Association in accordance with:
 - 1) Article 6(1)(b) of the RODO for the purpose of concluding and performing the contract;
 - 2) Article 6(1)(f) of the RODO on the basis of the Administrator's legitimate interest, where the Administrator's legitimate interest is to conduct communications related to the execution of the subject of the agreement, to direct any complaints and claims;
 - 3) Article 6(1)(c) of the RODO in connection with the performance of legal obligations arising from tax regulations, accounting regulations and archiving related documentation.
4. The data will not be transferred to other entities, except to entities authorized to process them under the provisions of law and entities supporting PZPN in the fulfillment of rights and obligations and in the provision of services, on the basis of concluded contracts, including those providing assistance and technical support for information systems, in which they are processed.
5. Personal data will be kept only for the period necessary to fulfill the purpose for which they were collected or for the period indicated by law, as well as for the duration of the maturity of any claims related thereto, i.e. for at least 6 years after the termination or completion of the contract - in accordance with the general statute of limitations under Article 118 of the Act of April 23, 1964 Civil Code (Journal of Laws of 2019, item 1145).
6. Representatives and contact persons whose data will be processed in connection with the performance of the contract have the right to request from the Administrator access to their personal data, rectification, deletion or restriction of processing, to object to data processing, data portability and the right to withdraw consent.
7. If the contact persons and representatives consider that the PZPN has violated their personal data, they have the right to lodge a complaint to the supervisory authority, which is the President of the Office for Personal Data Protection, based in Warsaw.
8. Personal data will not be subject to automated decision-making or profiling.
