

STADIUM RULES

FIFA U-20 WOMEN'S WORLD CUP POLAND 2026™

1. Scope

1.1. These Stadium Rules (hereinafter "Rules"), together with the relevant Organiser laws and any policies or procedures implemented in respect of sanitary measures, shall apply to all persons who enter the mass event area used in connection with the ongoing mass event (within the meaning of the Act on the Safety of Mass Events of 200 March 2009) FIFA U-20 Women's World Cup Poland 2026™ ("Competition") and applies to all matches (each a "Match") of the Competition.

1.2. The Rules apply to all mass event area, including all entrances and exits, as well as all other official areas and facilities (hereinafter "Stadium") that are accessible with an Accreditation, Match ticket or other admission document determined by FIFA and/or the Polish Football Association (the "Organiser").

1.3. Each person possessing a Ticket ("Ticket Holder") or any person granted access to the Stadium by an Accreditation ("Accredited Person") is required to adhere to these Rules at all times whilst inside the Stadium.

1.4. The Rules may be enforced by FIFA, Organiser and the respective Stadium management, including their employees, representatives, volunteers, stewards and administrators (collectively, the "Event Organisers") as well as any public authorities in charge of safety, security and public order at the Stadium including Police or other applicable law-enforcement and emergency services officials.

1.5. In cases where it is considered necessary in order to prevent, limit or eliminate any risk of death or personal injury, or damage to property, FIFA, Organiser, Stadium management, stewards, Police or other emergency services officials reserve the right to take exceptional measures and/or to give mandatory instructions, which must be followed. During all the time of standard Stadium operations, all instructions given by stewards or public authorities must be followed by all people who enter the Stadium.

1.6. FIFA and Organiser reserve the right to modify or revise these Rules. The latest and effective version is available online at [FIFA.com/tickets](https://www.fifa.com/tickets) and www.pzpn.pl and will be available at the Stadium. In addition, FIFA and Organiser reserve the right to develop additional policies specific to different categories of Ticket Holder and/or Accredited Person based on prevailing security measures and/or risk assessments.

1.7. Failure to comply with these Rules may result in expulsion from the Stadium and/or cancellation or revocation of Ticket(s) or Accreditation.

2. Entrance to the Stadium

2.1. People may only enter the Stadium with an Accreditation or a Match ticket acquired and used in compliance with the accreditation terms and conditions and ticketing terms and conditions (as applicable). A Ticket Holder or Accredited Person may only access the Stadium via the entrances indicated on their Ticket or Accreditation or as otherwise directed by the Event Organisers. Match tickets acquired or used in breach of ticketing terms and conditions shall be void. Any person seeking to use such Match ticket will be refused entry or will be deemed a trespasser and be evicted from the Stadium, and may be liable to further legal action.

2.2 Entrance to the Stadium shall only be authorised upon presentation of an Accreditation or valid Match ticket per person (regardless of age) and, upon request, proof of identity (such as ID, passport). The Match ticket as well as proof of identity must be shown and handed over for inspection on entry and inside the Stadium at the request of any steward and/or any other legally authorised persons representing the Organiser. Failure to comply shall result in access to the Stadium being denied or expulsion from the Stadium.

2.3 All persons, after entering the Stadium, must ensure that their Match ticket or Accreditation are available for inspection at the request of any steward and/or any other legally authorised persons representing the Organiser at any time. Accreditation devices must be worn around the neck with the side identifying the Accredited Person facing outwards.

2.4. Each Ticket provides to the Ticket Holder the right to a seat in the indicated location and/or category to that stated on the Ticket.

2.5. Minors under the age of 13 must carry their own Match ticket and shall only be authorised to enter the Stadium with an accompanying adult, who will be responsible for them. The accompanying adult shall also hold a valid ticket.

2.6. Driving and parking of vehicles inside the Stadium and/or within the Stadium perimeter shall only be permitted with the special authorisation of Organiser or FIFA.

2.7. The validity and usability of Match tickets shall be determined according to the relevant ticketing terms and conditions.

2.8. There is no re-admission to the Stadium. If a Match ticket grants access to two games within the same day, no exit will be allowed between the two Matches, unless strictly and explicitly approved by the Organiser.

2.9. Ticket Holders may enter the Stadium no earlier than the time indicated on their respective Ticket, which remains subject to change. Ticket Holders must promptly exit the Stadium following the conclusion of the Match unless instructed otherwise by the Event Organisers, stewards or other emergency services officials.

3. Personal Controls

3.1. All persons entering the Stadium must pass through safety and security screening at the point of entry. Persons and luggage are checked in accordance with the principles set out in applicable Polish law. Stewards or Police are entitled to examine – including through the use of technical aids – whether people are representing a security risk, especially whether they have consumed alcohol or drugs or are in possession of weapons or other prohibited items under these Rules. Stewards or Police are entitled to search any person's clothing and other items in their possession. Permission to enter, or to remain inside, the Stadium is at the absolute discretion of the Event Organisers.

3.2. Persons who engage in unauthorised use of an Accreditation or Match ticket, or who do not follow the instructions of Organiser or FIFA (or any official appointed by Organiser or FIFA) or any steward or Police officer at the Stadium may be denied access to the Stadium.

3.3. Persons who represent a security risk or who are subject to a local, national or foreign Stadium ban shall be denied access to the Stadium and shall immediately return their Match ticket to FIFA or the Organiser (as instructed), all without refund.

4. Conduct Inside the Stadium

4.1. All individuals entering the Stadium shall:

- (a) conduct themselves so they do not harm, injure, endanger or unnecessarily obstruct or annoy others, nor cause any damage;
 - (b) follow the instructions of Organiser or FIFA (or any official appointed by Organiser or FIFA) or any steward or Police officer present at the Stadium;
 - (c) occupy the seat allocated to them as per their Match ticket and use the appropriate access routes.
- If one becomes aware of any damage caused to any property or any accident of any kind such person should take immediate steps to inform Organiser or FIFA (or any official appointed by Organiser or FIFA) or any steward or Police officer at the Stadium.

4.2. Further exceptional demands may be made to prevent, reduce or eliminate danger to life, health or property. Instructions issued by stewards or Police must be followed and failure to cooperate may result in expulsion from the Stadium.

5. Sound and Image Recordings and Transmissions

5.1. Any individual attending a Match consents to being photographed, filmed or taped by the Organizer or FIFA or by any third parties appointed thereby, which shall have the right to use, broadcast, publish and license, without any requirement for payment of money or other form of consideration, of such person's voice, image and likeness by means of live or recorded video and/or audio display, broadcast or other transmission or recording, photographs or any other current and/or future media technologies.

5.2. Any individual attending a Match shall not take, record and/or transmit any sound, image and/or description of the Stadium or Match (as well as any result and/or statistics of the Match) other than for their exclusive, private and domestic use. It is strictly forbidden to disseminate over the Internet, radio, television or any other current and future media, any sound, picture, image, data, description, result and/or statistics of the Match in whole or in part for commercial purposes, or to assist anyone conducting such activities.

5.3. The Stadium area is subject to video surveillance in accordance with applicable law.

5.4. Any individual attending a Match must not take photographs and/or film any security procedures or restricted areas that are not available to the general public.

6. Prohibited Items

6.1. The following items are strictly prohibited at all times in the Stadium unless expressly authorised by the Event Organisers, where appropriate, such as in respect of Accredited Persons acting in accordance with the applicable terms and conditions of their Accreditation:

Hazardous Items

6.1.1. weapons of any kind (including for self-defence), ammunition or components of guns, electric incapacitation devices (tasers, stun guns, etc.), mace, pepper spray, or other chemical irritants, piercing or bladed items, knives, cold steel weapons or any other objects which enable the practice of violence;

6.1.2. explosives, detonators and items containing or concealing such prohibited items;

6.1.3. any other object which could be used as a weapon, to cut, or to stab, or as a projectile, or any object which could in the opinion of the Event Organisers endanger the safety of others, including any type of umbrella, motorcycle helmets, hard hats and other similar objects;

- 6.1.4. work tools of any kind;
- 6.1.5. body protection gear or corsets (unless permitted upon presentation of a medical prescription), including bullet-proof vests and items used in martial arts or extreme sports;
- 6.1.6. helmets as well as any other means of disguise or items specifically designed for concealing a person's identity, except for religious headwear, medical masks and face shields. Any permitted face covering must be removed upon request of the Event Organisers (for example, for the purposes of access and security screening);
- 6.1.7. except for cigarettes and electronic smoking devices (including those that heat tobacco), any materials, articles or objects (including self-made items), the use of which can result in the generation of smoke, heat and/or flames including lighters, matches, fireworks, flares, smoke bombs and other smoke-emitting articles, compressed and liquefied gases, combustible solids, poisonous or noxious or pungent substances, oxidising substances and organic peroxides;
- 6.1.8. toxic, radioactive, caustic or corrosive materials;
- 6.1.9. spray cans, corrosive and flammable substances, large permanent marker pens, paints or receptacles containing substances that are harmful to health or highly flammable;
- 6.1.10. aerosol cylinders, thermoses and flasks of any kind;
- 6.1.11. bottles, cups, jars, cans or any other form of closed or capped receptacle that may be thrown or cause injury, as well as other objects made of glass or any other breakable material or especially hard packages or hard thermal boxes.
- 6.1.12. sports equipment items (excluding clothing) such as inflatable balls of any size unless purchased within the Stadium, and frisbees;
- 6.1.13. other inflated or inflatable items, such as beach balls, balloons or any kind of inflated toys unless purchased within the Stadium;
- 6.1.14. bicycles, rollerblades, skateboards, kick scooters and electric scooters.;
- 6.1.15. large items such as stairs, benches, folding chairs, boxes, cardboard containers, large bags, backpacks, suitcases and sports bags. 'Large' means any objects exceeding 30x40cm on any two sides.
- 6.1.16. significant quantities of cardboard, paper or any rolls of paper;
- 6.1.17. any quantities of powdery materials, flour or similar substances (small make up elements, such as compact powder, shadows, blush, lipsticks, glosses and other are permitted);
- 6.1.18. any type of animal, except for assistance dogs Assistance dogs shall only be permitted if they are accompanying a disabled Ticket Holder with valid proof of eligibility or a disabled Accredited Person.

Food / Liquids / Consumable Items

6.1.19. With the exception of hand sanitizers, no larger than 100ml, any liquids containing alcohol, including any alcoholic beverages, unless purchased and consumed within designated areas of the Stadium and in strict accordance with any additional alcohol consumption rules imposed by the Event Organisers;

6.1.20. any other liquids exceeding 100 ml unless such liquids are purchased inside the Stadium, with the exception of (i) baby milk and sterilised water in containers (including in glass containers) not exceeding 1 litre per child,

6.1.21. any commercially produced and/or packaged food items and take-aways of any kind, except if acquired inside the Stadium or if adequate justification is provided (e.g., medical grounds) or for babies or young infants. Any permitted food items must be packed in receptacles that are not made out of glass, metal or other breakable material or otherwise in contravention of these Rules. Ticket Holders and Accredited Persons should be aware that items will be subject to inspection and disposal at the Event Organisers' discretion;

6.1.22. illicit drugs, narcotics or stimulants of any kind, except substances necessary for medical reasons.

Flags and Political / Offensive / Commercial Items

6.1.23. any materials, including but not limited to banners, flags, flyers, apparel and other paraphernalia, that are of a political, offensive and/or discriminatory nature, containing wording, symbols or any other attributes aimed at discrimination of any kind against a country, private person or group on account of race, skin colour, ethnic, national or social origin, gender identity and expression, disability, language, religion, political opinion or any other opinion, birth, wealth or any other status, sexual orientation or on any other grounds;

6.1.24. flags, banners and posters except those that do not exceed 2 meters x 1.5 meters or unless approved in advance by the Event Organisers in writing, provided in all cases that such flags, banners or posters are made of a non-flammable material, and are not in any other way prohibited under these Rules. All such items must be presented at the Stadium entrance with their respective written and signed authorization by the Event Organisers for inspection and final approval (pre-approval can be gained through the FIFA Fan Materials Portal);

6.1.25. flagpoles or banner poles of any kind, with the exception of flexible poles or so-called double poles made from non-flammable plastic or other pliable material that do not exceed 1 metre in length

and 1 centimetre in diameter, and are not otherwise deemed a safety or security risk by the Event Organisers;

6.1.26. any promotional or commercial object, apparel or other material including, but not limited to, banners, flags, signs, symbols and flyers or any type of object, material or clothing that, in the opinion of the Event Organisers, are promotional or commercial in nature;

Electronic, Musical and Telecommunication Items

6.1.27. radio-electronic or high frequency devices, or any other devices that may lead to an interruption or failure of broadcasting, IT or technology functionality at the Stadium;

6.1.28. any musical instrument (mechanical or manual) unless presented with the written preapproval of the Event Organisers. (Pre-approval can be gained through the FIFA Fan Materials Portal). The applicable Event Organiser may require Ticket Holders to stop using musical instruments if the sound emitting from the respective device interferes with event operations or the enjoyment of other Ticket Holders. Permitted musical instruments must never block, obstruct or otherwise restrict passages, gangways, staircases, entrances, exits or other access areas;

6.1.29. electronic, mechanical or manual devices that produce noise or other excessively loud sounds, such as vuvuzelas, horns, air horns, whistles, loudspeakers, megaphones etc. Heaters for drums are also prohibited. The Event Organisers may require Ticket Holders to stop using devices permitted inside the Stadium if the sound emitting from the respective device interferes with event operations or the enjoyment of other Ticket Holders;

6.1.30. instruments that emit laser beams, laser pointers or similar emissions;

6.1.31. any type of television and telecommunication equipment (including professional video cameras) or other professional equipment that is capable of recording sound and video (for the avoidance of doubt personal smartphones, tablets and photo cameras presented with a fixed or detachable lens less than 10cm in actual length are permitted);

6.1.32. more than one set of extra batteries or rechargeable units for any device which is permitted under these Rules. 1 power bank of any size is permitted per person;

6.1.33. any types of mounts for photo and video equipment, such as tripods, monopods and 'selfie' sticks;

6.1.34. drones and any device with the ability to be operated by remote control including toy aircraft, toy car, toy helicopter, blimp, and any remote controllers for such devices;

Other Prohibited Items

6.1.35. any other objects that could be used as a projectile or could cause harm upon being thrown or any item that may compromise public safety, cause fear, unrest, nuisance, interfere with the Competition's operations or the enjoyment of other Ticket Holders and/or harm the Competition's reputation, as determined by the Event Organisers at their absolute discretion.

6.2. Holders of a wheelchair user Ticket ("Wheelchair User Place Ticket Holders") are required to bring their own wheelchair or mobility scooter in order to access the Stadium. For security and operational reasons, no wheelchairs, mobility scooters or other kinds of seating will be provided to Wheelchair User Place Ticket Holders.

6.3. Inside the Stadium, Wheelchair User Place Ticket Holders are permitted to use manual or electric wheelchairs or mobility scooters with either three or four wheels, a maximum width of 70 centimetres and length of 130 centimetres, a maximum turning radius of 90 centimetres and turning width of 150 centimetres, and a maximum speed of 6 kilometres per hour. For safety and security reasons, wheelchairs or mobility scooters exceeding any of these restrictions are not permitted inside the Stadium.

6.4. Notwithstanding the terms in this Section 6, the Event Organisers reserve the ultimate right to make a final decision on whether any item brought to or into the Stadium is prohibited, and any decision must be respected. Attendees, Ticket Holders, or Accredited Persons who do not comply with the Event Organiser's final decision may be refused entry to, or removed from, the Stadium.

7 Prohibited Behaviour at the Stadium

7.1. Unless expressly authorised by the Event Organisers, where appropriate, such as in respect of Accredited Persons acting in accordance with the applicable terms and conditions of their Accreditation, all persons entering, inside and exiting the Stadium must:

7.1.1. conduct themselves in a way that does not cause harm, injury, danger, unnecessary obstruction, alarm or discomfort to others, and does not cause any damage to property;

7.1.2. follow any and all instructions given by the Event Organisers, stewards or other emergency services officials;

7.1.3. access only the Stadium areas permitted by their Ticket, or the Stadium areas determined by the function for which they hold an Accreditation, and they must access these areas only by the designated entrance(s), unless instructed otherwise by the relevant Event Organisers;

7.1.4. vacate their designated or occupied seat if instructed to do so by the relevant Event Organisers on grounds of safety and security;

- 7.1.5. dispose of waste correctly, according to the multi-bin system provided at the Stadium; and
- 7.1.6. immediately take the necessary steps to inform the Event Organisers, stewards or other emergency services officials if they are aware of an accident in or immediately surrounding the Stadium or any damage caused to any Stadium property.
- 7.2. Unless expressly authorised by the Event Organisers, where appropriate, such as in respect of Accredited Persons acting in accordance with the applicable terms and conditions of their Accreditation, all persons entering, inside and exiting the Stadium must NOT:
- 7.2.1. bring to, or store at, the Stadium any items prohibited under these Rules or any other applicable policies and procedures (for the avoidance of doubt, staff and volunteers are allowed to bring large bags for their personal items);
- 7.2.2. enter the field of play or areas immediately surrounding the field of play;
- 7.2.3. throw objects, substances or liquids of any kind, in particular towards another person or in the direction of the field of play or the area surrounding the field of play;
- 7.2.4. start a fire, release or throw fireworks, flares, guns, smoke bombs or other smoke devices, pyrotechnic devices, or other devices that produce similar effects;
- 7.2.5. restrict, obstruct or block passages, gangways, staircases and streets, entrances and exits to the Stadium, access to seating areas and emergency exits, or obstruct or interfere with open zones to traffic, or otherwise act in a way that could cause crowding in a manner that creates a risk of a stampede or public disturbance;
- 7.2.6. access, or facilitate access for others to, areas that are closed to the public or to which access is not authorised to Ticket Holders or under the terms and conditions of Accreditation, such as Stadium operations rooms, VIP rooms, press rooms, etc.;
- 7.2.7. engage in any anti-social behaviour, promote any violent, intimidating, threatening or damaging behaviour, or behave in such a way oneself, or demonstrate tendency to behave oneself in a violent, indecent, threatening and harmful manner or one that may disturb the public order or cause offence to a reasonable person;
- 7.2.8. act in a manner that may be perceived as dangerous, provocative, threatening, offensive and/or discriminatory or may cause a person to fear for their safety;
- 7.2.9. intimidate, bother, harass physically, sexually and/or mentally abuse any other person, including players and officials involved in the Match;
- 7.2.10. create any threat to life to oneself or others, or hurt or injure any person in any way;

- 7.2.11. stand on seats in the spectator areas or unreasonably obstruct the view of Ticket Holders in any way, including standing in Stadium areas reserved for disabled spectators and spectators with limited mobility;
- 7.2.12. climb structures and installations prohibited for general use, such as closed fences, walls, wire fences, barriers, light poles, camera platforms, trees, pools or roof tops;
- 7.2.13. use clothing or other items to conceal the face or obstruct the person's identity, other than face masks worn for health and medical purposes, or national, cultural and religious headwear;
- 7.2.14. curse or chant in a political, offensive and/or discriminatory manner or use foul or abusive language or obscene gestures;
- 7.2.15. act in an offensive or obscene manner by streaking, flashing, removing items of clothing or otherwise remain in a state of undress (including being shirtless) or reveal intimate body parts. For the avoidance of doubt, body tattoos and body paint do not constitute clothing.
- 7.2.16. be visibly under the influence of alcohol, narcotics or any narcotic substance. Alcohol may only be consumed in moderation, in strict accordance with any additional alcohol consumption rules imposed by the Event Organisers and always in accordance with Philippine legislation with respect to age limits and other restrictions. Alcohol must not be offered to persons under the legal drinking age (note, if there are reasonable grounds to believe that someone is intoxicated as a result of alcohol and/or drug consumption, that person may be refused certain services and may be refused access to, or removed from, the Stadium);
- 7.2.17. relieve themselves in any place other than a designated toilet, or litter in the Stadium by dropping objects such as trash, packaging, empty containers, etc.;
- 7.2.18. smoke, vape or use any tobacco products as well as any electronic smoking device;
- 7.2.19. damage vegetation, gardens, landscaping, cultural or natural heritage sites;
- 7.2.20. use devices that generate excessive noise or that interfere with the playing or viewing of football matches, excluding devices approved by the Event Organisers as being intended for expressing support for football teams and players participating in the Competition;
- 7.2.21. practise any other conduct that may interfere with the comfort, safety or enjoyment of the Competition for any other Ticket Holder, Accredited Person, player or Match official, or that may disrupt the sporting nature of the Competition;
- 7.2.22. disrupt the operation of Stadium utilities, including power supply, lighting (including emergency lighting), ventilation, water supply, sewerage, air conditioning or any other systems;
- 7.2.23. secure flags, banners or posters to surfaces of structures and installations at the Stadium, cover CCTV cameras or air conditioning systems, place flags, banners or posters on the court side

perimeter walls (unless permitted otherwise by the Event Organisers), or otherwise use flags for any reason other than in a festive and friendly manner. Upon the request of the Event Organisers, Ticket Holders must immediately remove, stop demonstrating and/or permit the confiscation of any flags, banners or posters;

7.2.24. write, paint or post anything on structural elements, installations or passages;

7.2.25. possess, use, display, disseminate, promote or transmit any materials (including but not limited to banners, flags, flyers, apparel and other paraphernalia) of a political, offensive and/or discriminatory nature, containing wording, symbols or any other attributes aimed at discrimination of any kind against a country, private person or group on account of race, skin colour, ethnic, national or social origin, gender identity and expression, disability, language, religion, political opinion or any other opinion, birth, wealth or any other status, sexual orientation or any other grounds;

7.2.26. sell or offer to sell any goods or Tickets, gather and/or distribute materials (including printed materials such as flyers, booklets and publications, advertising materials and apparel) or any objects whatsoever, raise funds or conduct other promotional or commercial activities without the prior written consent of FIFA (including demonstrating discernible brands or trademarks of legal entities or individuals for advertising purposes) nor conduct any other types of promotional or propaganda activities;

7.2.27. solicit donations in cash or in kind (including but not limited to musicians, singers or collectors of charitable donations at the Stadium surroundings or on Stadium premises) without written authorisation from the Event Organisers;

7.2.28. conduct any activities relating to gambling, betting or court siding, including wagering of money or value-in-kind on an event and/or Match with an uncertain outcome;

7.2.29. conduct any activities related to predicting or attempting to predict sport results for financial gain;

7.2.30. relay and/or transmit, via mobile or other devices, the live Match scores or any other activity related to the Competition or information about Match activities that is announced via the public address system and/or giant screens located within the Stadium;

7.2.31. practise any other activities that may compromise public safety and/or harm the reputation of the Competition, the Event Organisers or any public authorities in charge of safety, security and public order at the Stadium, as determined by the Event Organisers in their discretion;

7.2.32. take any photographs, record sound or video of any security procedures or restricted areas that are not available to the general public.

Any individual attending a Match must not take photographs and/or film any security procedures or restricted areas that are not available to the general public.

7.3. Any breach of the Rules may result in the following penalties being imposed:

- (a) expulsion from the Stadium and possible handing over to the Police;
- (b) cancellation and invalidation of the Match ticket and banning of the offender from all next matches organised by Organiser and/or FIFA;
- (c) provision, in accordance with applicable laws, of the relevant personal information to respective national football associations and/or the Police so that appropriate measures can be taken, e.g. national stadium bans;
- (d) initiating by Organiser and/or FIFA or any other authorised persons or entities of legal proceedings;
- (e) any other penalties or remedies in accordance with applicable laws.

Organiser and/or FIFA reserve all other rights to pursue other legal remedies at their own discretion.

7.4. FIFA and the Organiser reserve the right to make alterations to the time, date and location of the Match due to unforeseen extraordinary circumstances: force majeure, safety and/or security reasons or other decisions made by any competent authority which have a major impact on the Match being played at the Stadium.

8. Liability

Any individual attending a Match acknowledges they do so at their own risk and that they may be liable for damage or loss resulting from any of their acts at the Stadium.

9. Severability and Amendments

9.1. Should any provision of the Rules be declared void, ineffective or unenforceable by any competent court, the remainder of the Rules shall remain in effect as if such void, ineffective or unenforceable provision had not been contained.

9.2. Organiser and FIFA reserve the right to make reasonable amendments to the Rules from time to time, the latest and effective version of which shall be available on www.pzpn.pl, fifa.com/tickets and at the Stadium.

9.3. During the Match (ongoing mass event), these Rules shall take precedence over any other rules or regulations of the same or similar subject matter which may be applicable to the Stadium during other periods.

10. Authentic Text

10.1. The Rules have been drafted in Polish and translated into English. In the event of any discrepancy between the texts, the Polish text shall prevail.

11. Applicable Law and Jurisdiction

11.1. The Rules shall be governed by and interpreted in accordance with the laws of Poland.

11.2. All disputes arising from or related to the Rules shall be submitted to the competent court in Warsaw.

11.3. In matters not regulated by the Rules, the relevant provisions of Polish law shall apply, in particular the Act on the Safety of Mass Events of 20 March 2009.
